You may receive a charitable deduction. When the trust term ends, your family receives the remainder interest at substantial tax savings.	<ul style="list-style-type: none"> • Gift or estate tax deduction • Asset and appreciation passes to family at a reduced transfer cost 	CHARITABLE LEAD TRUST (CLT)
<ul style="list-style-type: none"> • Remain in your home for life • Receive a current charitable income tax donation 	You gift property to UJF / designated organization but retain the right to use the property during your life.
