### KIDSPLACE FINANCIAL POLICIES

- I. KidsPlace is offered as a full-month program with a minimum enrollment of two (2) months.
- II. Fees are for full-month participation and will not be prorated.
- III. At no time will any payments made toward KidsPlace be refunded. This includes lost program time due to any possible closure of KidsPlace and/or the JCC that may become necessary in order to comply with best-practice policies related to health and safety. Further, all payments made to KidsPlace are non-transferable and cannot be applied to JCC membership or to any other program within the JCC.
- IV. Discount: A Sibling Discount of \$10 per month is applied to all siblings except the first child in the family, for the period of time that all are enrolled in KidsPlace. This discount is based on and applied to KidsPlace Program Fees only; Before Care and After Care fees do not qualify.
- V. Registration in the program will renew automatically in two- (2-) month increments, and automatic billing will continue on a monthly basis, until or unless a parent's written request to terminate the registration is received with a minimum of one month's notice: e.g., to withdraw a child after October 31<sup>st</sup>, written notification must be received by the KidsPlace office not later than September 30<sup>th</sup>; otherwise, the child's registration will remain active and automatic billing will proceed monthly.
- VI. If a parent withdraws a child from the program, the child's place will not be held, but rather he/she must reapply in order to rejoin the program, as space permits.
- VII. Deposit and Payment Schedule:
  - > A deposit in an amount equal to one month's program-only fee (\$780) is payable at the time of registration. If the registration is not canceled within 72 hours of submission, the deposit becomes non-refundable and will be charged in full to the designated credit card, in payment of the first month's program fee. Any balance due for the After Care portion of the monthly fee (\$195) will be charged on the next regularly-scheduled program billing date.
  - > The balance of all fees due beyond the deposit will be billed on a monthly basis via automatic charges to the designated credit card. Installments will be processed on the 28<sup>th</sup> of each month, beginning in August, continuously until or unless the child withdraws from the program as described above in section V.
  - > If no space is available at the time an application is submitted and the parent chooses to join the Wait List, a deposit of \$500 per child will be charged to the designated credit card and held until a space becomes available, at which time the deposit will be credited toward the first month's billing and registration will proceed as described above. The \$500 deposit for the Wait List is refundable only if a space does not become available.

Please Note

The structure of KidsPlace 2020-2021 is subject to change in order to support the prevailing Stamford Public School model. In the event that SPS would undertake an all in-person model, the structure of the KidsPlace program would be modified accordingly.
