This is a financial agreement between you and the Jewish Community Center (JCC) and is binding for the period of September 2026 to August 2027.

1. Annual tuition for each child is **\$34,475**. When more than one sibling is enrolled in the same year, a 10% discount will be applied to the lesser annual tuition(s). Although you may choose to pay your tuition in monthly installments of **\$2,873**, your signature on this agreement commits you to the full amount of the annual tuition.
2. A non-refundable deposit of **\$2,872** must be paid when registering. Provided all financial obligations and terms of this agreement have been met, your deposit will be applied to your final tuition payment.
3. In addition to annual tuition, a non-refundable \$500 per student security fee will be charged prior to the first day of school for the 2026/27 school year.
4. Installments are payable by credit or debit card only. MasterCard, Visa and American Express are accepted. Installment payments are processed automatically on the first of each month, beginning August 1, 2026 for all new students and on September 1, 2026 for all returning students. You are responsible for notifying the JCC Finance Department of any changes to your payment information (lost or stolen card, expiration date changes, etc.). Payments that are declined by your bank are subject to applicable service charges.
5. Jewish Community Center family membership is a requirement at the time of registration. Membership must remain active and in good standing throughout your child's time in KinderPlace.
6. In the event your JCC account is in arrears by more than 30 days at any time, your child may not be allowed to attend KinderPlace until such time as payment is made current.
7. Fees paid to the JCC, whether for KinderPlace tuition, membership dues or other related fees, are non-refundable. Furthermore, fees are not transferable to other JCC activities or for payment of fees for other family members. Early withdrawal of your child from KinderPlace does not excuse your obligation as to remaining tuition payments, and your deposit will be forfeited.
