



Electronic Funds Transfer Program

The **Electronic Funds Transfer (EFT)** program provides a way to budget your annual JCC fees on a monthly basis. With your authorization, membership dues, Building Fund contributions, and certain program fees are charged monthly to an account of your choosing. The EFT program offers you **affordability** – monthly payments are easier on your budget – **convenience** – you save time and mailing costs, there are no checks to write, and no worries about on-time payments – and with **no additional fees** – there are no service charges when using our EFT plan.

Any adult, 18 years of age or older, who has a valid MasterCard, Visa (credit or debit cards) or American Express card, is eligible to pay via EFT. Just complete this form and return it to the Membership or Accounting department.

Membership Payment Terms and Conditions

1. I understand that this a continuous membership plan, with a minimum commitment of 12 months. It will remain in effect for as long as I retain the JCC membership cards issued to me.
2. I understand that if I wish to terminate after a minimum of 12 months or change my membership in any way, I must give the JCC a minimum of 30 days written notice. There will be a \$100 termination fee for memberships cancelled within the first 12 months.
3. The JCC may, at its discretion, adjust the monthly rate applicable to my membership category no more than once in any 12 month period.
4. Should any payment not be honored by my card issuer for any reason, I understand that I am still responsible for the payment, in addition to a service charge of \$25 applied by the JCC. This is in addition to any service fee my card issuer may make. I understand that I must notify the JCC in writing should I change my account information (including expiration date) in any way.
5. Membership cards remain the property of the JCC and must be surrendered upon request.
