 - ° Placement in the 3 Day Threes Program can be in a class that meets on Monday/Wednesday/Friday OR on Tuesday/Thursday/Friday.
- JCC Sara Walker Nursery School Administration will have sole discretion, and will apply educationally sound criteria, in making all placement decisions.
- Children in 5 Day Programs must be toilet trained.

APPLICATION PROCESSING GUIDELINES

- Applications to the JCC Sara Walker Nursery School are accepted from current JCC members only when accompanied by a \$500.00 non-refundable, non-transferable tuition deposit.
- Priority enrollment for continuing families (including incoming siblings) will be accepted beginning November 18, 2019.
- Beginning December 2, 2019, applications from all JCC member families will be accepted and reviewed on a first-come, first-served basis.

PAYMENT TERMS AND POLICIES

- Tuition deposits paid upon application are not contingent upon assignment to specific days of the week.
- At no time will any payments made toward tuition (including deposits) and NSPA dues be refundable. Further, payments made toward tuition (including deposits) and NSPA dues are non-transferable and cannot be applied to membership or to any other JCC program.
- For your child to begin school in September, your family must be JCC members in good standing, with dues and other obligations current for the 2020-2021 school year. Children will not be permitted to begin school if the family is in arrears on the payment of dues, tuition or other JCC fees. Please be sure that payments are made promptly.
- Limited financial assistance, in the form of scholarships, may be available. Applications for financial assistance may be obtained from the JCC Membership Services office. Completed applications for financial assistance, with proper documentation, must be received no later than March 15, 2020.
- Acceptance into the JCC Sara Walker Nursery School is on a school-year basis (September 2020 to June 2021), and tuition for the entire year is due and payable by May 1, 2020. However, as an accommodation in easing the financial burden on our families, we offer two alternate payment plans:

- **TWO PAYMENTS: May 1 (50% of total tuition plus NSPA dues) and December 1, 2020 (50% of total tuition less \$500 deposit)**
These payments may be made by check, American Express, Visa or MasterCard (credit and debit cards accepted). If paying by credit or debit card, the account used for the May 1st payment must have an expiration date of December 31, 2020 or later. This account will be charged automatically for the final tuition payment. The NSPA dues will be included in the first tuition payment.
- **EIGHT PAYMENTS: May 1 through December 1, 2020 (roughly equal monthly installments of the tuition balance, plus NSPA dues with the first installment)**
This option is available only via a credit or debit card with an expiration date of December 31, 2020 or later. Your account will be charged automatically on the first day of each month. The NSPA dues will be included in the first tuition payment.

Note that a registration submitted and accepted after March 31, 2020 may require a customized payment plan consisting of fewer installments and/or installments spaced closer together, so that the tuition balance will be paid in full no later than December 1, 2020.

- Regardless of the payment option chosen, and whether or not the child completes the school year, the full annual tuition amount remains the obligation of the family. All unpaid installments in your chosen payment agreement become due and payable in full immediately upon withdrawal of the child from the school.
- Any child or family can be denied entry or have their enrollment terminated at the sole discretion of JCC Sara Walker Nursery School Administration.

AGREEMENT AND ACCEPTANCE
